#### Meeting Minutes - Open Session Meeting

Wednesday, June 12, 2024

- A. Meeting Called to Order at 6:05pm by Board of Directors President S. Brown
- B. Directors Present: P. Malone, D. Gomez, B. Cammarota, A. Hutson, B. Six, S. Brown. 1 vacant seat as J. Weaver sent letter of resignation. Also present is General Manager S. Cook.

#### C. Open Forum

- a. Complaint regarding the Summer Pool Party and Potluck. Child was denied a Hotdog because member did not contribute. Board President S. Brown issued a public apology and noted that this should not have and will not in the future. Social committee was instructed that participation in community events is not based on contribution. General Manager S. Cook was instructed to write up a Letter of Apology for S. Browns signature and to include in The Acorn billing insert and in the Oak Leaf newsletter.
- b. It was also noted that at the Summer Pool Party and Potluck, Committee, Board Members, and volunteers should be more social.
- c. Member questioned if Yard Pickup was still happening. General Manager S. Cook confirmed that Yard waste pickup is still happening on Monday's and Friday's. Yard waste must be bundled or contained in a bag or trash can and be out on the curb by 8am.
- d. Member noted that we should have a camera at the school bus stop. Member
- e. Member inquired regarding the status of the firebreak on the Buena Vista Road side of the community. General Manager noted that the firebreak is being worked on by Maintenance.
- D. It was noted that J. Weaver sent in a Letter of Resignation, resigning her seat as director effective 5/8/2024. 1 director seat was posted as open with nominations being accepted through 6/3/2024.

- I. A. Hutson motioned to Accept the May 2024 Financials as presented. B. Cammarota seconded the motion. Motion passed 6-0-0-1vacant seat.
- J. Solar Update. Construction has begun. That is what the repetitive pounding that is being heard throughout the community is. As of today, the expected go live date is October 2024. This date is subject to change and will be updated monthly. Solar asked to confirm color for fence. Color confirmed at best match to current fencing on Jackson Valley Road. Brown or Redwood. It was affirmed that since the Solar Rate will be better than the PGE Cares rate the Care and Medical Baseline rates will only be included at the True-up.

#### K. Design Reviews:

Hutson motioned to approve Policy/Resolution 2024-3 giving pre-approval authorization to management for Design Reviews that have minimal aesthetic impact on the community such as a new roof, paint, home repair etc., of similar material and color. - P. B. Cammarota motioned to approve the Guest/Overflow parking enforcement proposal as presented. Parking for 72 hours then received a parking violation. After 24 hours tag with tow notice allow 96 hours. Then the office will call for a tow. Signage was placed at the entrance and an Extended parking permit was presented. P. Malone seconded the motion. Motion passed 6-0-0-0-1 vacant seat. The Board President noted that undisclosed Guest/overflow parking along Oak Road be identified by painting green, outlining, and numbering spaces to match the rest of the guest/overflow parking.
